#### Preamble

The Performance Agreement is entered into between the Director General and Chief Statistical Officers of the (Survey and Data Processing Division and Population Housing and GIS Division) of National Statistics Bureau (NSB)

The objectives of this Performance Agreement are:

- a) To establish clarity and consensus about annual priorities for the National Statistics Bureau (NSB) consistent with the 11<sup>th</sup> Five Year Plan document, and Government's new priorities;
- b) To make the Division fully responsible for driving implementation and delivering the results against the annual priorities;
- c) To provide an objective and fair basis for evaluating the Division's overall performance at the end of year;

The Performance Agreement represents an important accountability mechanism for inculcating a performance based culture at Division levels of NSB.

**NOW THEREFORE**, the parties hereto agree as follows:

#### Section 1: NSB's Vision, Mission and Objectives

#### Vision

- Support evidence-based policy/decision making in the country; and
- Be a key provider of world class statistical information.

#### Mission

- Provide timely, relevant and reliable statistics consistent with international principles and standard for effective decision making and monitoring; and
- Be a key provider of internationally comparable statistical information.

#### **Objectives**

#### The objectives of the National Statistics Bureau are to:

- 1. Develop national statistics development strategy (NSDS);
- 2. Draft statistics bill of Bhutan (Statistical Legislation);
- 3. Conduct socio-economic and thematic research;
- 4. Conduct population housing census of Bhutan (PHCB);
- 5. Collect and publish monthly, quarterly and annual official statistics reports;
- 6. Develop environmental statistics and accounting;
- 7. Develop micro-data dissemination policy;
- 8. Develop standard operating procedures for survey/census clearance; and
- 9. Establish geog level data centre in two pilot Dzongkhags.

# Section 2: Roles and Responsibilities of the Survey and Data Processing Division (SDPD) are as:

- 1. Responsible for conducting case studies;
- 2. Nationwide surveys and publish reports; and
- 3. Besides, the division is also responsible to extend technical support to the sectors and conduct training in the field of data collection and survey methodology.

# Section 3: Roles and Responsibilities of the Population Housing and GIS Division (PhGISD) are as:

- 1. Database Management of Population and Housing Census Spatial information;
- 2. Building the spatial database for Dzongkhag and Geog level statistically through GIS platform;
- 3. Integration of Statistical information and the GIS database;
- 4. Development of Geo-database for socio-economic indicators in reference to National Geo-coordinate system;
- 5. Maintenance of Socio-economic geo-database for online information dissemination to the user organizations;
- 6. Customer oriented information extraction from the National Geo-database;
- 7. Confirming with the national standard with Centre for GIS Coordination (CGISC) in the field of technology advancement, Meta data, Data acquisition and data compatibility;
- 8. Meeting the training user needs in the field of GIS applications for GIS user communities;
- 9. Compilation of Statistical information from different user organizations for further dissemination through spatial data; and
- 10. Preparation of Socio-Economic Indicator GIS Atlas.

#### **Objectives**

## The objectives of Divisions (SDPD and PhGISD) are to:

- 1. Conduct population housing census of Bhutan (PHCB);
- 2. Develop micro-data dissemination policy; and
- 3. Establish geog level data centre in two pilot Dzongkhags.
