



Consumer Price Index (CPI): May 2026

(Release date: 7th July 2026)

1. National CPI

1.1 Headline Inflation (Year-on-Year) – National level

The headline inflation in May increased to 7.72 percent. This increase was mainly driven by an increase in both the Food and Non-food indices.

Figure 1: Year-on-year Inflation, National (% change)

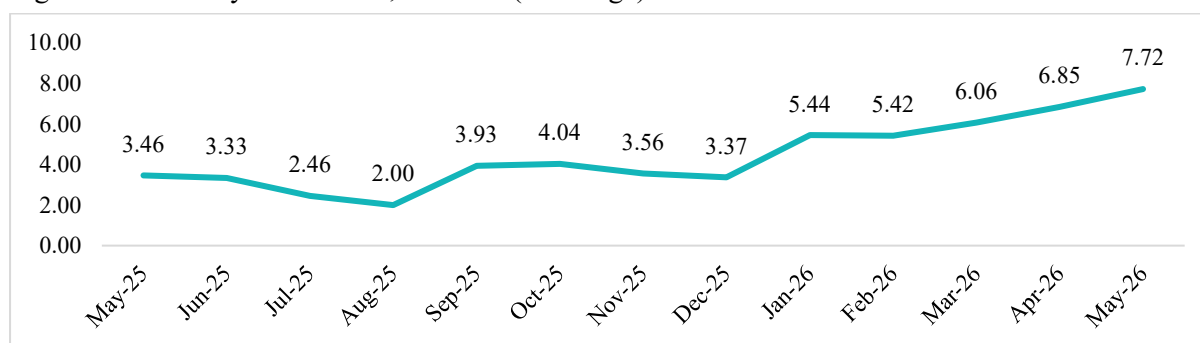
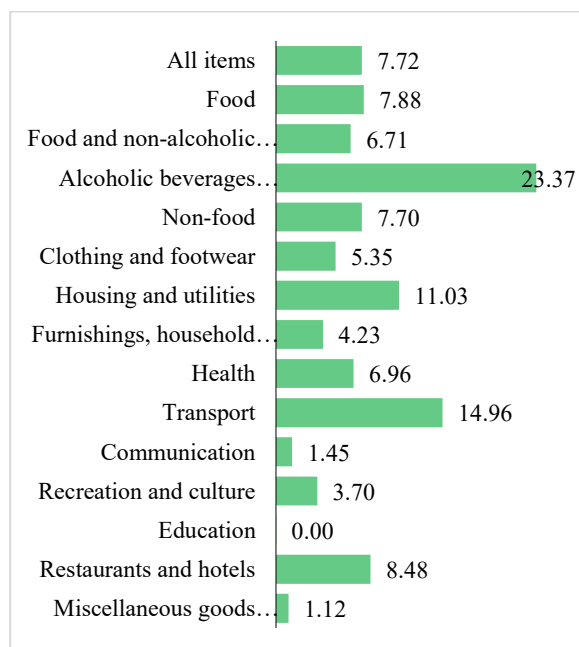


Figure 2: CPI by major categories, Y-O-Y (% change)



Food Inflation

The Food inflation increased to 7.88 percent in May 2026. Within the Food category, the Food & non-alcoholic beverages index recorded an increase of 6.71 percent, and the Alcoholic beverages & betel nuts index saw a decrease of 22.37 percent.

Non-food Inflation

The Non-food inflation increased to 7.70 percent in May 2026. Under non-food, the Transport index increased to 14.96 percent, followed by the Housing and Utilities index which increased to 11.03 percent, and the Restaurants & hotels index increased to 8.48 percent.

1.2 Headline Inflation (Month-on-Month) National Level

The month-on-month inflation decreased to -0.64 percent in May 2026. This decrease was driven by decreases in the indices of both Food and Non-food.

Figure 3: Month-on-Month Inflation, National (% change)

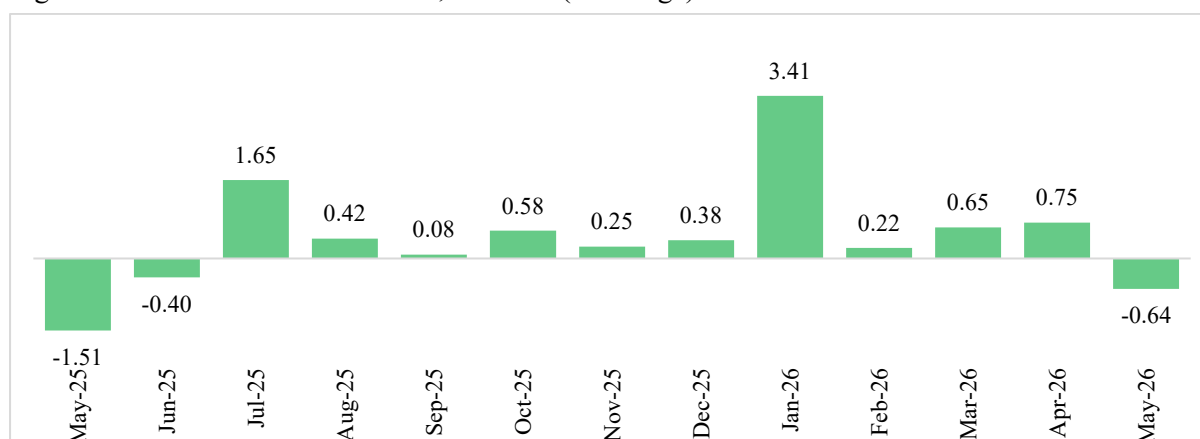
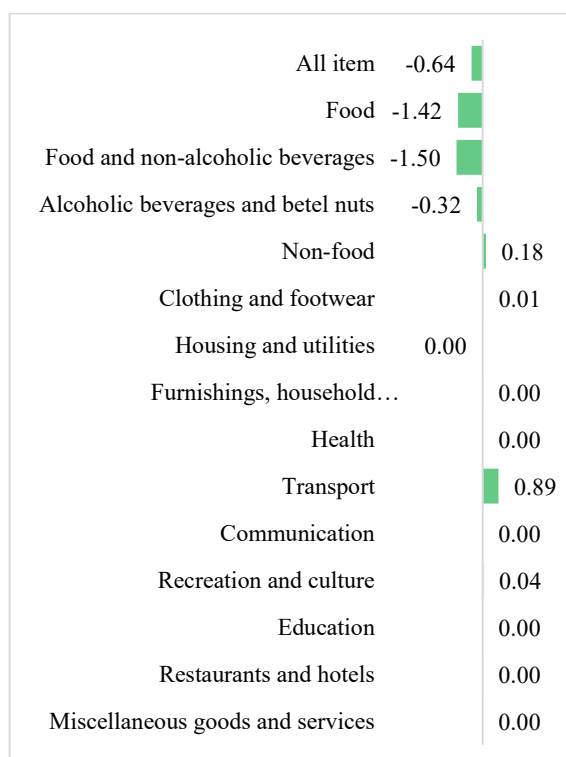


Figure 4: CPI by major categories, M-O-M (% change)



Food Inflation

Month-on-month Food inflation decreased to -0.64 percent in May 2026. This downward trend was driven by decreases in the Food & non-alcoholic beverages index to -1.50 percent, while the Alcoholic beverages & betel nuts index decreased to -0.32 percent.

Non-food Inflation

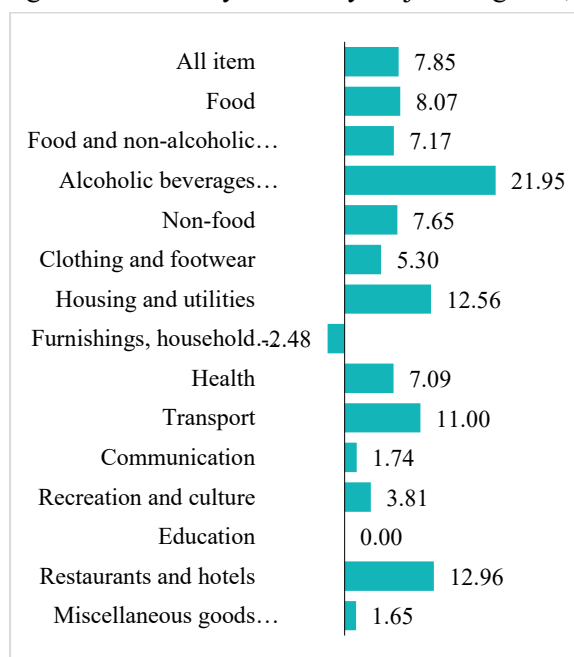
Month-on-month inflation for Non-food increased to 0.18 percent in May 2026. The Transport index saw and the highest increase of 0.89 percent, followed by the Recreation and Culture index which increased to 0.04 percent.

2. Capital City CPI

2.1 Capital City CPI (Year-on-Year)

Year-on-year inflation for the Capital City increased to 7.85 percent in May 2026. This increase was driven by a 8.07 percent rise in the Food index and a 7.65 percent increase in the Non-food index.

Food inflation increased to 8.07 percent. Within the Food category, the index for Food & non-alcoholic beverages rose to 7.17 percent, and the index of Alcoholic beverages & betel nuts increased to 21.95 percent.

The Non-food index increased to 7.65 percent. This increase in index was mainly driven by a 12.96 percent increase in the Restaurants & hotels index, followed by a 12.56 percent increase in the Housing & utilities index. The Transport index also saw an increase of 11.00 percent.

2.2 Capital City CPI (Month-on-Month)

Month-on-month inflation for the Capital City decreased to -0.68 percent in May 2026. This decrease was mainly driven by decreases in the Food index.

Food inflation decreased to -1.62 percent. Within the Food category, the index for Food & non-alcoholic beverages fell to -1.73 percent and the index of Alcoholic beverages & betel nuts remained the same as April 2026

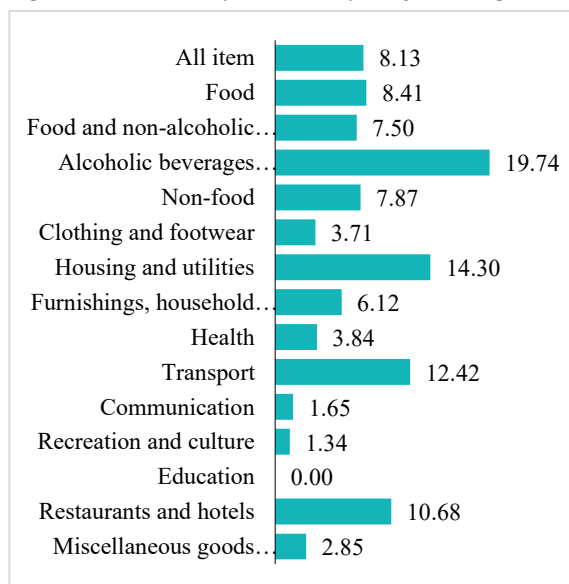
The Non-food index increased to 0.19 percent. This increase was mainly driven by a 0.87 percent increase in the Transport index, followed by 0.02 percent increase in Furnishings, household equipment and routine household maintenance index. Meanwhile, the Housing and Utilities decreased to -0.01 percent.

3. Central Region CPI

3.1 Central Region CPI (Year-on-Year)

In May 2026, the year-on-year inflation for the Central region increased to 8.13 percent.

Figure 7: Year-on-year CPI by major categories, Central (% change)



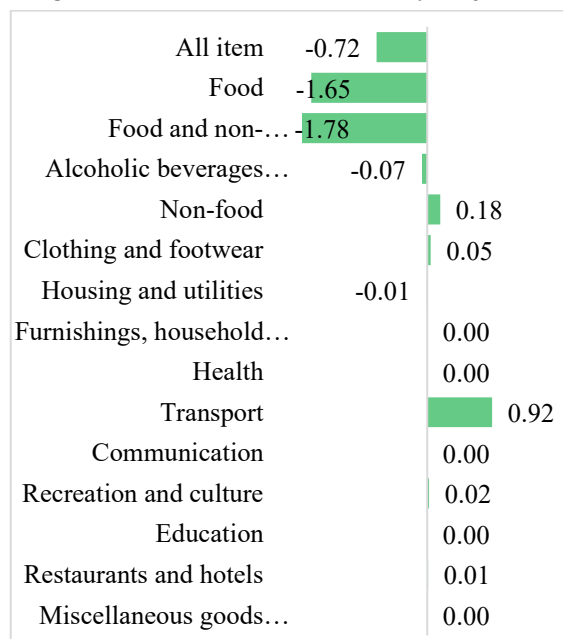
The Food inflation increased to 8.41 percent, largely driven by a 7.50 percent increase in the index of Food & non-alcoholic beverages and a 19.74 percent increase in the index of Alcoholic beverages & betel nuts.

The Non-food inflation increased to 7.87 percent. This increase was mainly driven by a 14.30 percent increase in the Housing & utilities index, followed by a 12.42 percent increase in the Transport index, and a 10.68 percent increase in the Restaurants and Hotels index.

3.2 Central Region CPI (Month-on-month)

In May 2026, the month-on-month inflation for the Central region decreased to -0.72 percent compared to the previous month.

The Food inflation decreased to -1.65 percent, largely driven by a -1.78 percent increase in the index of Food & non-alcoholic beverages, and -0.07 percent increase in the Alcoholic beverages & betel nuts index.

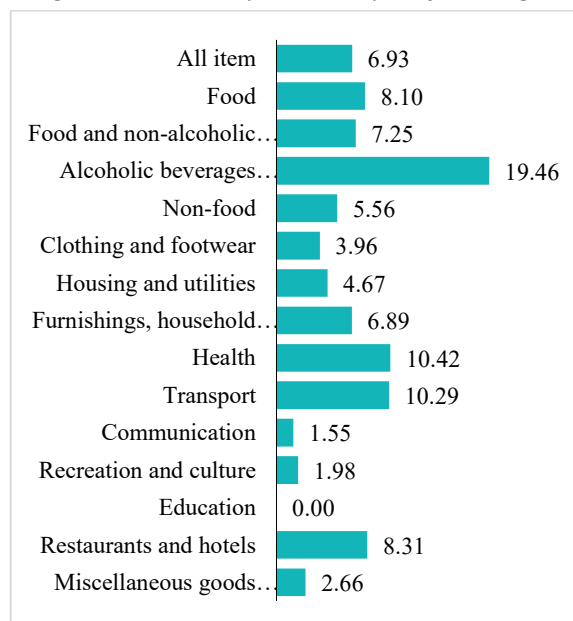
The Non-food inflation increased to 0.18 percent, mainly driven by a 0.92 percent increase in the Transport index, followed by a 0.05 percent increase in the Clothing and Footwear index. Meanwhile, similar to the Capital City, there are decreases in the index of Housing and Utilities to -0.01.

4. Eastern CPI

4.1 Eastern Region CPI (Year-on-Year)

In May 2026, the year-on-year headline inflation rate for the Eastern region increased to 6.93 percent, mainly driven by increase in both the Food and Non-food indices.

Figure 9: Year-on-year CPI by major categories, Eastern (% change)



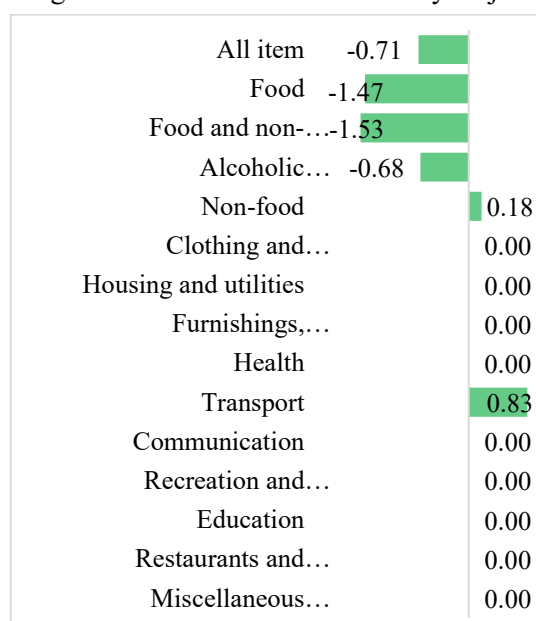
Food inflation in the Eastern region increased to 8.10 percent in May 2026. The Food & non-alcoholic beverages index increased to 7.25 percent and the Alcoholic beverages & betel nuts index increased to 19.46 percent.

Non-food inflation increased to 5.56 percent. This upward trend was mainly driven by a 10.42 percent increase in the Health index, followed by a 10.29 percent increase in the Transport index and a 8.31 percent increase in the Restaurants and Hotels index.

4.2 Eastern Region CPI (Month-on-Month)

In May 2026, the month-on-month headline inflation rate for the Eastern region decreased to -0.71 percent, driven by decrease in the Food index.

Food inflation in the Eastern region decreased to -1.47 percent in May 2026, driven by the Food & non-alcoholic beverages index which decreased to -1.53 percent, and the Alcoholic beverages & betel nuts index which decreased to -0.68 percent.

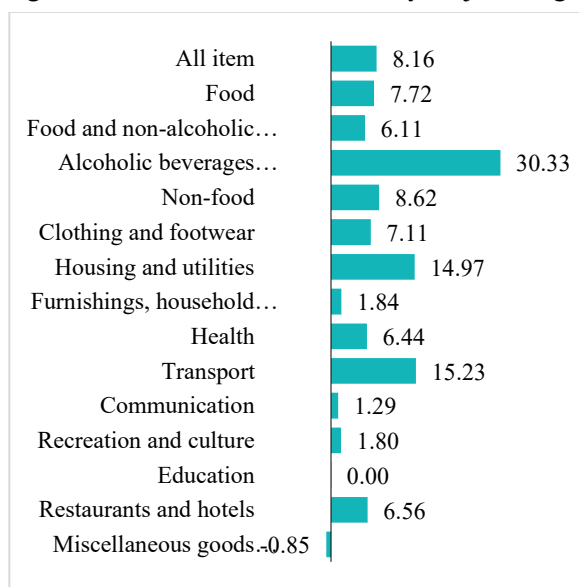
Non-food inflation increased to 0.18 percent, mainly driven by the Transport Index, which saw an increase of 0.83 percent

5. Western CPI

5.1 Western Region CPI (Year-on-Year)

In May 2026, the year-on-year headline inflation of the Western region increased to 8.16 percent, driven by an increase in both Food and Non-food indices.

Figure 11: Month-on-month CPI by major categories, Western (% change)



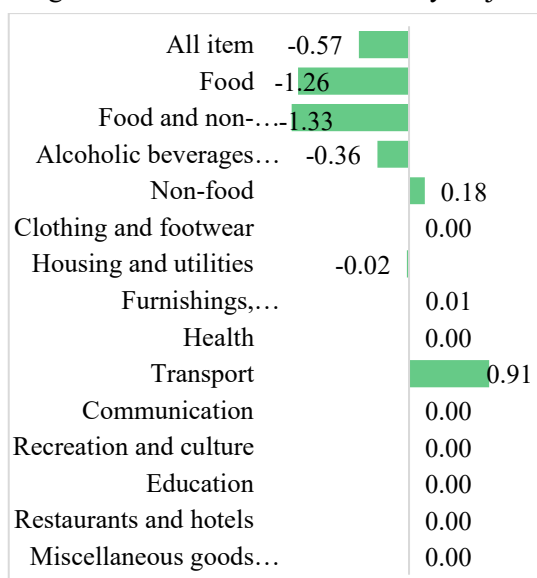
Food inflation recorded an increase of 7.72 percent in May 2026. This upward trend in food inflation was mainly driven by a 6.11 percent increase in Food & non-alcoholic beverages index and a 30.33 percent increase in the Alcoholic beverages & betel nuts index.

Non-food inflation in the Western region recorded an increase of 8.62 percent. This was driven by a 15.23 percent increase in the Transport index, a 14.97 percent increase in the Housing and Utilities index, followed by an 7.11 percent increase in the Clothing and Footwear index.

5.2 Western Region CPI (Month-on-Month)

In May 2026, the month-on-month headline inflation of the Western region decreased to -0.57 percent. This was mainly driven by a decrease in the index of Food.

Food inflation recorded an decrease of -1.26 percent in May 2026. This trend in food inflation was mainly driven by a -1.33 percent decrease in Food & non-alcoholic beverages index, while the Alcoholic beverages & betel nuts index saw a drop of -0.36 percent.

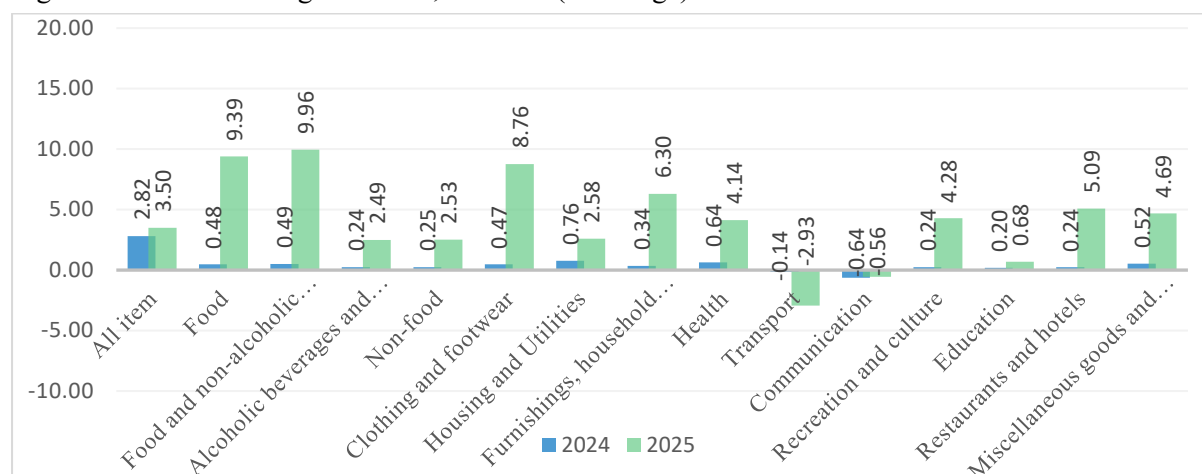
Non-food inflation in the Western region recorded an increase of 0.18 percent. This was mainly driven by a 0.91 percent increase in the Transport index, followed by a 0.01 percent increase in the Furnishings, household equipment and routine household maintenance. Meanwhile, the Housing and Utilities index saw a drop of - 0.02 percent.

6. Annual Average Inflation, National

The annual average national headline inflation from January 2025 to December 2025 increased to 3.50 percent in 2025, up by 0.69 percentage points from 2.82 percent in 2024. The upward trend in inflation was primarily driven by a steadier annual increment in food and non-food index.

Average food inflation increased to 9.39 percent in 2025. This increase was due to the increase of Food & non-alcoholic beverages index to 9.96 percent and that of Alcoholic beverages & betel nuts to 2.49 percent.

Figure 13: Annual average inflation, National (% change)

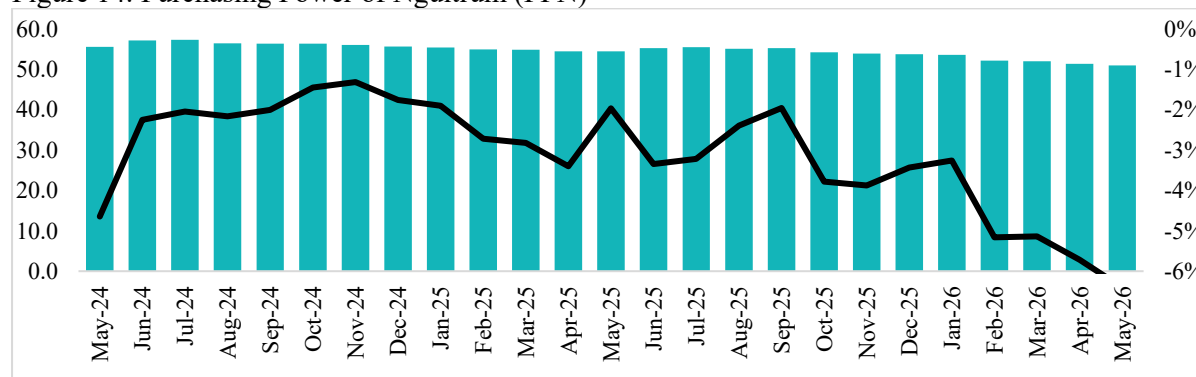


In 2025, the non-food index increased to 2.53 percent, from 0.25 percent in 2024. This increase was mainly driven by the Clothing & footwear index which increased to 8.76 percent, closely followed by Furnishings, household equipment and routine household maintenance which increased to 6.30 percent. The communication and transport index dropped to -0.56 percent and -2.93 percent respectively.

Purchasing Power of Ngultrum

The purchasing power of the Ngultrum, as measured by CPI, stood at Nu. 51.3 as of May 2026 as compared to December 2012. This means, Nu. 100 in May 2026 is worth only Nu. 51.3 at December 2012 prices. The Purchasing Power of the Ngultrum has eroded by -7.17 percent in the last year (from May 2025 to May 2026) due to price increases in the economy.

Technical Note

1. Background

The Consumer Price Index (CPI) measures how the prices of consumer goods and services change over time on average. It helps to measure inflation, indicating if prices have decreased or increased from a specified reference period, called the base year. This index base year is used as a benchmark against which current price levels are compared. The CPI provides information on the purchasing power of consumers and the overall cost of living.

2. Scope and Coverage

The CPI includes the goods and services bought by households. A representative sample of these goods and services is selected based on household expenditure data. Prices for these sampled goods and services are collected from urban areas in the 20 Dzongkhags at different frequencies—monthly, quarterly, and annually - depending on how often the prices change. Data collection outlets are chosen through purposive sampling based on the popularity of the outlet and the availability of items.

To capture the price dynamics across various regions of the country, five different CPIs are being published monthly, starting from June 2024. The number of items included in each of the CPI baskets is as follows:

1. National level : 169 items
2. Eastern : 120 items
3. Western : 165 items
4. Central : 144 items
5. Capital City : 134 items

The items in the CPI are classified according to the *Classification of Individual Consumption According to Purpose (COICOP) 1999*. Approximately 500 outlets are selected for pricing.

3. Weights

The weights reflect the relative importance or share of expenditure on individual items within the total consumption expenditures for all households. These weights determine the impact each item has on the overall inflation. The weights for the current CPI are derived from the household consumption expenditure data of the Bhutan Living Standard Survey (BLSS), 2022 conducted every five years. The new rebased CPI basket along with its corresponding weights for National, Capital City, Western, Central, and Eastern are given below.

4. Reference Period

There are three “reference periods” used for CPI as given below:

- i. **Weight Reference Period** is the period during which household consumption expenditure data are collected. The weight-reference period for the new CPI is 2022, that is, the period when the BLSS was conducted.
- ii. **Index Reference Period** is the period when the index is set to 100. In the new CPI, the index reference period is 2023-24 (May 2023 to April 2024).

- iii. **Price Reference Period** is the period for which the prices of each product are used for calculating the elementary indices (indices for individual CPI items). The price reference period for the new CPI is April 2024.

5. Index Calculation

The Geometric Modified Young formula is used to calculate the CPI:
